Tier-3: Damage claim above AED 15,000 up to replacement value, you will be paying only minimum deductible amount of AED 10,000 excluding the machine off rent charges.

Please note, the damages due to operator negligence/error will not be covered.

The Manlift Damage Protection Plan is a simple way to ensure that whatever happens to Manlift equipment during your rental period, you will only be liable for an agreed upon deductible amount. Basically, when you sign on for the Manlift Damage Protection Plan you buy yourself peace of mind and very significantly reduced liability for any damage to the rented equipment that may occur.

How does it work?

When you rent Manlift equipment, you can purchase the Manlift Damage Protection Plan for a small surcharge. The plan covers just about any damage that could possibly

occur, and your liability will be limited to a deductible that is far less than the value of the equipment. Even if the damage is total loss, you won't have to pay anything above the deductible. The only exclusions are for damage caused by deliberate misuse of the equipment, or for foreseeable damage, such as corrosion caused by using the equipment in a salt mine.

Any Material Damage

Any material damage means just that – from damage to accidents to mechanical breakdowns to fire or theft. As a result of human error or an “act of God” like a storm or a flood. At any time from the first day to

the last day of the rental period. All you need to do is to fill in a simple form describing the damage and Manlift will take care of the rest.
